## 1. Working as a Chartered Professional Accountant (CPA) (NOC 1111)

### *Job Description*

**Chartered Professional Accountants** organize and analyze the financial records and transactions kept by businesses and individuals.

You perform the following duties:

- plan, set up and maintain accounting systems
- provide financial, business and tax advice
- prepare financial statements, reports and income tax returns
- ensure accuracy and compliance with established accounting standards and procedures
- project future earnings and cash requirements
- assist with financing initiatives to secure bank or equity funding
- act as trustees in bankruptcy proceedings

## ***Industry Overview***

In Canada all three accounting designations, CA / CMA / CGA have merged under the Chartered Professional Accountant (**CPA**) designation. Intermediate level accounting professionals who don't meet the requirements to register as a CPA may choose to obtain the Advanced Certificate in Accounting and Finance (**ACAF**) designation.

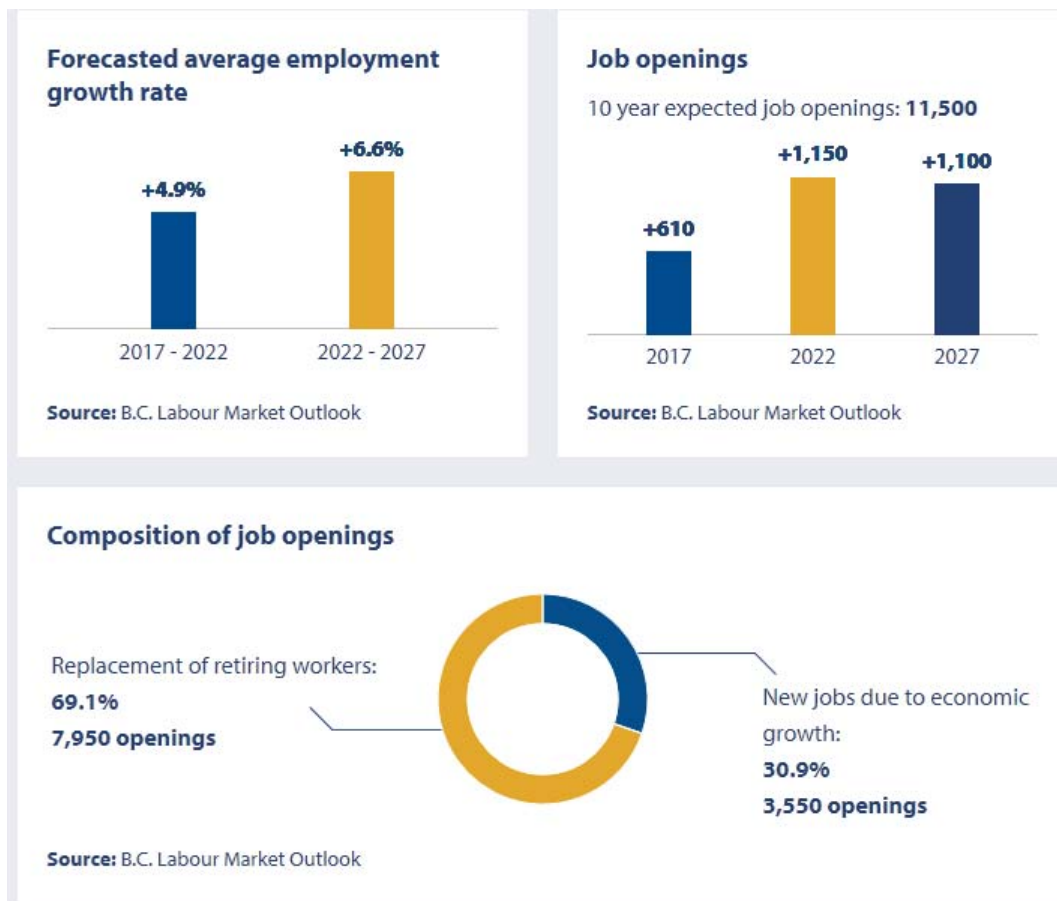
CPAs and ACAFs have a variety of employment opportunities and are in high demand in BC.

Demand for tax, financial instrument, forensic accounting, bankruptcy and information experts is increasing, and demand for accountants specializing in a specific industrial sector may also be on the rise.

With the rise of international trade, job opportunities are opening for accountants who speak additional languages.

### ***Working Hours***

You generally work between 8 and 10 hours a day, 40 to 50 hours a week. You may have to work nights and weekends if an important deadline is approaching.

## 2. Skills, Education and Experience

### **Skills**

- Strong verbal and written communication skills
- Ability to share financial results, explain projections, report the impact of financial decisions and prepare detailed reports on audit findings
- Work well independently and as part of a team

### **Education and Experience**

#### **CPA**

- Canadian post-secondary degree or equivalent is required
- successful completion of the CPA Professional Education Program (PEP)
- successful completion of the Common Final Examination (CFE)

#### **Advanced Certificate in Accounting & Finance (ACAF)**

- Individuals without a Canadian post-secondary degree may choose to qualify as an *ACAF*, which is an intermediate level accounting professional. The *ACAF* qualification may be ideal for internationally trained accountants wanting to work in Canada.
- a minimum of one year study at a recognized post-secondary institution or ability to meet the entry requirements through prior work experience is required
- completion of the Advanced Certificate in Accounting and Finance program
- successful completion of the *ACAF* National Examination

Click on "Start Search" beside Canadian Businesses, then select the "Advanced Search" button. Select both "Keyword/SIC/NAICS" under Business Type and "City" under Geography. In the top search box enter "*accountants*" and click LOOKUP. Select the appropriate headings. Lower down, select the Province, choose the cities, and click the "View Results" button.

In Canada, employers usually expect to receive a resume or curriculum vitae and a cover letter that identifies the position you are applying for and summarizes your relevant experience.
